

COVID-19 Vaccination Policy for Students and Exemption Requests

Berea College recognizes that there are some situations in which it may *not be possible* for some persons to take advantage of the protection of vaccination for COVID-19. Accordingly, the College will consider requests for medical and religious exemptions to the College's COVID-19 vaccination policy. Requests for exemptions on other grounds will not be considered. Please be advised that unvaccinated students may be excluded from certain educational, co-curricular, or extracurricular activities for reasons of safety.

This statement outlines the process governing exemption requests. It takes effect on August 15, 2021, at the start of the Fall 2021 Term. It continues in force for the Spring 2022 Term, when students are required to receive the booster shot when eligible. **Students are required to submit any requests for exemptions and supporting documentation by 5:00pm on January 11, 2022, to the Office of Student Life (LSL@berea.edu).**

Please note that students who received religious or medical exemptions for vaccination prior to the Fall 2021 Term and who wish to continue to be exempted from vaccination must request a continuation to the Office of Student Life (LSL@berea.edu). No further documentation is necessary in that case.

Medical Exemptions

A medical exemption to vaccination is permitted only in the case where vaccination poses a *definite, definable, physical risk* of significant harm to an individual. Such a request must be accompanied by a physician's statement pertinent to the individual explaining in detail the nature of the harm that will be experienced by the individual, should the individual be vaccinated. The individual seeking exemption must complete the College's medical exemption request form and include clinical evidence supporting the request. The form will be distributed by the Student Life division using SmartSheets. Please email your request for the medical exemption form to LSL@Berea.edu.

The College, acting through the Vice President for Student Life with advice from White House Clinics and other medical consultants, will make decisions regarding medical exemption requests by **January 13, 2022**. Please note that the College may not be able to accommodate all such requests safely and reasonably. All such decisions are final and non-appealable within the College.

Religious Exemptions

A religious exemption to vaccination is available only to individuals who have a sincerely held belief in a religion that has, as one of its established tenets, a prohibition against vaccination for any and all illnesses. The individual seeking exemption must complete the College's religious exemption request form and include specific documentation regarding the religion's tenets

prohibiting vaccination. The form will be distributed by the Student Life division using SmartSheets. Please email your request for the religious exemption form to LSL@Berea.edu.

The College, acting through the Vice President for Student Life and the Willis D. Weatherford, Jr. Campus Christian Center, will make decisions regarding religious exemption requests by **January 13, 2022**. Please note that the College may not be able to accommodate all such requests safely and reasonably. All such decisions are final and non-appealable within the College.
